Export Restrictions

Export of Wilcox Industries products is controlled by The U.S. Department of Commerce under Export Administration Regulations (EAR) and the U.S. Department of State, Directorate of Defense Trade Controls, Bureau of Political-Military Affairs, in accordance with 22 U.S.C. 2778-2780 of the Arms Export Control Act (AECA) and the International Traffic in Arms Regulations (ITAR).
